We'll be hosting a regional workshop introducing a new initiative by LWVNY pairing our ongoing voter registration activities with increasing awareness of organ donation. Led by LWVNY, it offers us an opportunity for open discussion on other topics as well. Bring your questions and suggestions on Saturday, **May 9, at 11:00 AM**.

And finally, our **Annual Meeting** is scheduled for **Wednesday, May 27, at 4:00 PM** at Locust Hill Country Club. This is your opportunity to review and vote on the budget for 2015-16 and bylaws revisions, and to elect new members to the board of directors. (Please see pages 7 and 8 for the details.) And of course, we'll take this opportunity to celebrate our accomplishments over the last year – and the amazing members whose hard work made good things happen.

We're making some format changes this year – first and foremost, it's very affordable. **The cost is \$10 per member**, and we offer hors d'oeuvres, punch, coffee/tea and a cash bar. April Forum

The Affordable Care Act (ACA) was adopted by Congress in March 2010 after overcoming a gauntlet of obstacles including a polarized political environment and soaring budget deficits. Since then, the Act's constitutionality was affirmed by the U.S. Supreme Court in 2012, but its implementation was marred by the botched rollout of the health insurance exchanges in 2013. Although the exchanges worked largely as intended in 2014, a pending Supreme Court case and Republican majorities in both houses of Congress call into question both the future and form of the ACA.

"The Fifth Anniversary of the Affordable Care Act: Challenges of Implementation"—a community forum—will be held on Monday, April 27, at 7:00 PM at the First Unitarian Church on South Winton Road to ponder the challenges. This Forum is co-sponsored by the Social Justice Council of the First Unitarian Church.

The panel will be moderated by Sarah Liebschutz, Professor Emerita, SUNY, Brockport and League member. Panelists will provide insight into various dimensions of health care under the ACA. Bryan Hetherington, Empire Justice Center, will analyze *King v. Burwell*, a pending Supreme Court case about whether subsidies in the ACA can be provided to low- and middle-income enrollees in states with federally operated insurance marketplaces. Kim Wynn, Coordinated Care Services, will discuss local success rates of enrollment in the New York State of Health exchange. Christine Wagner, St. Joseph's Neighborhood Center, will reflect on access to health care for persons exempted from coverage in the ACA. The 90-minute forum will provide ample time for questions and answers about the implementation of the ACA.

Please mark your calendar and join us on April 27 at 7:00 PM at the Unitarian Church as we explore implementation challenges of the Affordable Care Act five years after its enactment.

Advocacy:

THE VOTING RIGHTS ACT

With the current focus on the 50th Anniversary of the Selma March, many citizens across the country are becoming aware or renewing their awareness of the 1965 Voters Rights Act and the Supreme Court ruling that has led to a needed updating of the Act. There has been a great deal of media coverage of new election regulations, especially since the Supreme Court's Shelby County decision. LWVUS and many others recognize this decision as making it harder for people to vote.

However, there also has been action to stop some of these new barriers to increasing voters' participation in our representative democracy, along with some new regulations that may increase voter turnout in 2015. LWVUS, as always in its 95 year history, is in the forefront of this movement to increase voter participation in our country. The Florida League (LWVFL), in an amicus brief, has stopped the state from purging the voter rolls. The League in Nebraska and Colorado, along with voting rights coalition partners, has prevented voter ID laws. In Michigan, South Carolina and elsewhere, members are lobbying for early voting. Online registration may happen in Florida, Iowa, Michigan, Minnesota and Oklahoma this year.

PEOPLE'S VOTING RIGHTS MANIFESTO

LWVUS joined the People's Voting Rights Manifesto on March 8, 2015 during the re-enactment of the Salem March. The Manifesto reads in part: "...we commit to protecting the right to vote by ensuring that everyone is registered and educated on the issues..."

We must tell our members of Congress to show support for democracy by pressing for the Voting Rights Act of 2015 to receive a hearing before the US House of Representatives Judiciary Committee this spring.

LWVRMA is committed to registering voters, informing citizens on candidates' positions (Vote 411) and getting citizens to the polls. The power of the vote impacts every aspect of our lives from the womb to the tomb.

Advocacy: NYS Budget

LWVNYS gave testimony on February 26 on the Governor's 2015-2016 proposed public protection budget as set forth in the Appropriations bill and the related Public Protection and General Government Article VII legislation. We in the League have lobbied for years for many of these items, but do not support including them in the budget process. Our position is that ethics reforms, election administration and campaign finance enforcement should be separate bills individually debated. LWVNYS looks forward to the 2015 session producing meaningful changes in contribution limits for state offices, closing of the LLC loophole completely and expanded disclosure of campaign expenditures. We strongly support public financing of elections.

Additionally, LWVNYS testimony supported monies to upgrade the 2007 NYSVoter, a statewide database and integrated list of each of the county boards' voter registration data, which serves as the single, official voter registration list. This system of recordkeeping of the 7,000 poll sites in our state and registration needs to be modernized, including the use of electronic poll books in the 2016 election.

LWVNYS Constitutional Convention Position

Consensus Meeting Update

At the LWVNYS convention two years ago, the delegates voted to update the current Constitutional Convention position with an emphasis on the method of delegate selection.

We will have a meeting for LWVRMA members to discuss the proposed updated position on Monday, May 4, at 7:00 PM in the Brighton Town Hall. The purpose of the consensus meeting will be to determine whether there is member agreement on updating the Delegate Selection portion of the League 1993 Constitutional Convention position:

- to make it more flexible and adaptable for the future (bringing it more in line with most League positions), and
- to clarify how the board should consider any reforms or lack thereof to the delegate selection process as part of the decision on whether or not to support the proposal for a constitutional convention when it comes up again for a vote in 2017.

This update is not intended to consider whether or not the League will support or oppose the proposal. The state board will decide that question in light of current policy concerns and the entire League position.

There will be only one question: Do we wish to retain the current position or do we wish to adopt the new position? Please join us as we help LWVNYS prepare for the 2017 ballot question on whether or not to have a Constitutional Convention.

New York State ranks LAST of all states and DC in the percentage of residents (18 years of age and older) who have registered to be organ donors (23%). Yet, NYS has the 3rd highest need for donors in the US. New York State is also the only state in the country that includes organ donation registration on the voter registration form.

With this partnership, local Leagues will provide information on organ donor registration at voter registration drives.

Dollars & Cents for 2015-16

Budget Committee members Dorothy Borgus (Chair), Barbara Hendry, Ida Holloran, Mary Hussong-Kallen and Gloria Read have been busy preparing the League budget for 2015-16. The budget received Board approval at the March 12 meeting, and is presented for your review on page 8 in this Voter.

In reviewing the 2015-16 budget you will note that the format has changed somewhat. Most significantly, some items have been moved off-budget, some line items have been clarified to better describe the expense or income involved, and there has been a consolidation of some administrative costs, namely postage, copying and the cost of brochures. Previously many of these costs were budgeted under specific programs or events, making overall cost difficult to track. The committee feels these changes will make the Board's fiscal monitoring and oversight easier as well as adding transparency to the League's finances.

Overall, the committee feels that this is a moderate budget which takes advantage of the educational dollars in our Grants Management Account and exercises judicious spending while still producing good programs and fulfilling the mission of the League.

Bylaws Committee Report

Our bylaws committee reviewed the rules which govern LWV-RMA's operations and recommends the following five changes. All changes were accepted by the Board of Directors at its March 12 meeting:

Article V, Section 1 – "The terms of office for all elected directors shall begin on July 1st following the election. (*previously immediately following election*)

Article V, Section 1 – Appointed directors shall serve until June 30th following their appointment. (*previously unspecified*)

Article V, Section 9 (new) – When matters arise upon which the board must vote between scheduled board meetings, information may be distributed electronically and by telephone, and votes may be received by the Secretary by those same methods. This activity should be noted in the minutes of the following board meeting.

Article VII, Section 2 – An annual meeting shall be held between May 1st and June 15, the exact date to be determined by the board. (*previously April 15*)

Article VII, Section 2f – The minutes of the annual meeting shall be approved by the Board at the first regular meeting of the Board following the annual meeting not more than thirty (30) days after July 1st. (*previously not specified; historically the meeting took place immediately following the annual meeting*)

In addition to these recommendations, several miscellaneous changes were made in the interest of clarifying or fixing typographical errors.

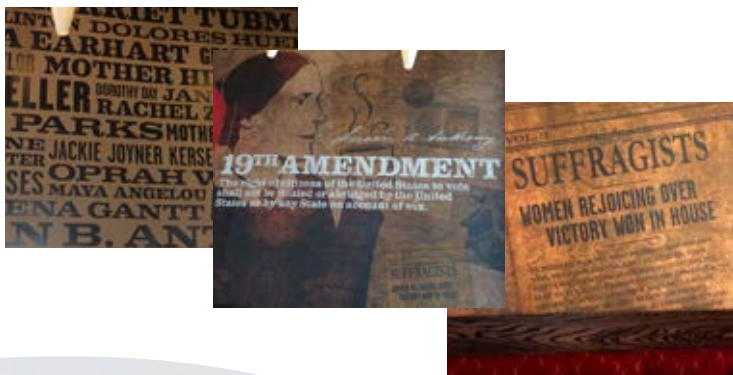
