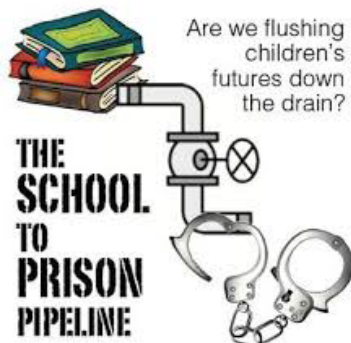

February Forum

Our Education Study Group is planning a forum for February 23, 2015 at 7:00 PM. The focus will be on the innovative programs that are being used to dismantle the “school to prison” pipeline here in the Greater Rochester area.

This forum has been “in the works” since League members Georgia DeGregorio and Barbara Grosh attended an October 28, 2014 presentation entitled “**What’s My Fate?**” showcasing Michelle Alexander’s book, **The New Jim Crow: Mass Incarceration in the Age of Colorblindness**. After attending this discussion, the idea of hosting a community forum was discussed and planning began.

The forum will be held at Asbury First United Methodist Church on East Avenue and will be moderated by Asbury’s pastor, Rev. Lawrence Hargrave. The panelists include Monroe County Assistant District Attorney Shani Curry-Mitchell and Elaine Spaul, Director of the Center for Youth. These panelists will provide insight into the ways in which their programs are successfully helping to stem the tide of incarceration among Rochester’s most troubled youth.

The 90-minute forum will provide ample time for questions and answers after each panelist’s presentation. Issues such as job training, career readiness, alternatives to suspension programs, and many other current topics will help to make this a unique look at this complex issue and an interesting and hopeful journey. (Please note, this forum will partner with our March 23 presentation which will examine the Grand Jury system.)

Please mark your calendar and join us on February 23 as we begin to explore answers and solutions to a problem that has plagued our community and our country for many years.

UPDATE ON THE WEA

The New York State Senate passed eight bills of the Women's Equality Agenda on January 12, 2015. The votes were 62 to 0. The Assembly Speaker announced that the WEA vote in the other chamber would be one vote on the entire 10-point WEA package. During the Senate debate Senators Robach and Funke spoke in strong favor of each bill. The 2015 Senate bills cover fair pay, paid family leave, childcare, domestic violence, sexual harassment, pregnancy accommodation and human trafficking. GOVERNOR ANNOUNCES SUPPORT OF "CIRCUIT BREAKER" FOR PROPERTY TAXES

Since 2006 the League has supported folding the entire STAR program into a real property "circuit breaker" plan. Additional state funds are necessary for using the foundation formula approach for education. LWVNY accepts the implementation of a tax cap only in conjunction with an entire change in financing education. After studying proposals for 25 years, we adopted these positions in 2006 after a year-long study. Additional funding required to provide all children with "a sound basic education" (as decided by the NYS Court of Appeals) should be provided by means of the state personal income tax, implemented in a progressive fashion. The circuit breaker program should be based on need and indexed to inflation.

HEALTH CARE SYSTEM IN NYS

LWVNY supports a single payer system for health care for all New Yorkers. Assembly Health Care Committee Chair Richard Gottfried held six hearings in the last two weeks of December 2014 on this issue. Co-President Mary Hussong-Kallen, 1st VP Katherine Smith and two LWV-RMA members, Sarah Liebschutz and Carole Hoffman, attended the Rochester hearing on December 8. Among the many benefits of this plan is the potential to lower real estate taxes because Medicaid expenses would be removed from county tax bills. In addition, using general state taxes would reduce administrative costs and aid coordination of regional planning.
