### RAISE THE AGE (Concurrence Meeting)

On December 8th, 7:00 p.m. at Kendal Conference Room A, we will hold a concurrence meeting to address *Raise the Age*. In October we held a program on this topic. Below is a statement from the speaker Carol Mellor.

“Ohio state studied this topic thoroughly and shared their position with our New York State Board of Directors. The Board decided that because of the in depth study completed by Ohio, we did not have to conduct our own study of the issue. Instead, local Leagues throughout New York would be asked to consider concurrence with part of the Ohio's position.”

The concurrence positions we are asked to consider are as follows:

- (1) Children under the age of 18 are not adults and their treatment within the juvenile justice

system and criminal court system should relate to their stage of development.

- (2) Children should not be held in adult jails.
- (3) Rehabilitation is the purpose of the juvenile justice system.
- (4) The legal rights of children should be protected.

On December 8th a brief presentation will be given before we ask you to consider these four points for concurrence. The presentation was developed by the New York State League.

I hope you will come to the meeting and share your thoughts.

**WOMEN’S EQUALITY LEGISLATION**

***Governor Announces \$6.4 Million for Sexual Assault Prevention and Assistance Providers***

Governor Andrew M. Cuomo ... signed multiple pieces of legislation designed to protect and further women’s equality in New York State. The new laws will help achieve pay equity, strengthen human trafficking laws and protections for domestic violence victims and end pregnancy discrimination in all workplaces.

The Governor also announced that New York State has allocated a total of \$6.4 million for

Sexual Assault Prevention and Assistance providers across the State. This includes \$4.5 million enacted as part of the Enough is Enough legislative package to support implementation of this new campus sexual assault legislation by providing prevention, as well as \$1 million to be administered by the Department of Health and \$900,000 to be administered by the Office of Victim Services.

“This State has a legacy of leading the way in advancing equal rights – and today, we are making New York a model of equality for women,” said Governor Cuomo. “This comprehensive set of laws will help to ensure that women are supported, protected and given all of the opportunities they deserve in life. Today, New York stands once again as a monument for progress, and a sign of what can be achieved when we come together to do the right thing for women everywhere.”
