Voter education is one of the League's most important functions, and the League encourages all citizens to register and to cast an informed vote.

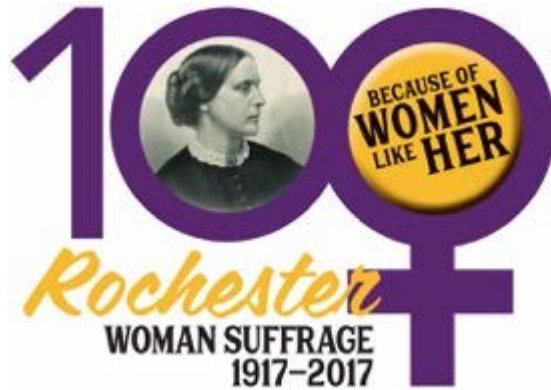
The League does not support political parties or candidates, but does take stands on important issues after careful study and research.

### ACTUAL V. BUDGET 2016-2017

Total revenues for the 2nd quarter are \$14,647.03 (\$18,410.63 YTD) v. Annual budget of \$20,720.00.

### REVENUES FOR THE QUARTER ARE -

- \$5360.00 memberships,
- \$110.00 donations,
- \$3200.00 Board of Elections payments,
- \$13.71 interest,
- \$2325.00 other income (notably \$2000 for AFSCME election), and
- \$3638.32 transfer/payments to our credit from the education fund, most notably 50 percent of our annual state and national PMP.

Total expenses for the quarter are \$6,600.72 (\$10,179.79 YTD) v. Annual budget of \$20,720.00.

### EXPENDITURES FOR THE QUARTER ARE -

- \$4647.00 for our full annual national PMP and 50 percent of our state PMP,
- \$48.00 PayPal fees,
- \$200.00 phone,
- \$51.00 postage,
- \$600.00 Voter layout,
- \$701.00 events/program (facility fees and supplies), and
- \$354.00 admin expenses including P.O. Box rental and web hosting for the year.

As a result there is a net surplus of revenue over expenses of \$8,046.31 for the quarter and \$8,230.84 YTD.

## Early Voting

NYS is one of fourteen states in the US that does not have some form of early voting. There is a movement in New York this year to change this so there will be an increase in voting turnout in 2017. The LWVNYS has the following position on early voting:

- There should be early voting for two weeks before Election Day, inclusive of two weekends, with at least some weekday voting hours scheduled before and after typical business hours.
- In advance of the first day of the early voting period, each county should provide public notice of the days, hours and location for early voting.
- Revisions of election procedures should be implemented to limit costs by such practices as using electronic poll books.
- There should be state funding.
- A uniform standard among counties for minimum number of voting sites should be established.

Early voting bill numbers are A2064 (Kavanagh) in the Assembly and S2950 (Stewart-Cousins) in the Senate. Please call your NYS Senator and Assembly offices and state your support for early voting in NYS by the time of the November elections.

## Election Law Priorities LWVNYS 2017

LWVNYS testified before the Joint Legislative Public Hearing on January 31, 2017 in support of a single June primary date, as put forth in A3052 (Cusick) and S3562 (Stewart-Cousins). Primaries need to be consolidated. LWVNYS supports the primary being held in June to comply with the Military Overseas Empowerment Act. Multiple primaries, as NYS witnessed in 2016, confuse citizens and create fiscal burdens for local municipalities.

LWVNYS supports ballot design changes that would make it easier for citizens to read and use the ballot. The Voter Friendly Ballot Act, A3379 (Kavanagh) and S1512 (Avella), directs that the ballot clearly distinguish between offices with a bold vertical bar and a fine line between the candidates with a large font and fill-in circles in black not gray.

LWVNYS also supports updating voter registration procedures, whereby 16- and 17-year-olds be allowed to register, as put forth in A1070 (Kavanagh) and S1661 (Carlucci). There should also be same day registration, as put forth in A2090 (Kavanagh) and S2478 (Gianaris). Same day registration would require an amendment to the NYS Constitution. ## Voter Education Team

The Voter Education Team uses several methods to maximize the number of American citizens registered to vote, that most American of democratic freedoms. We visit college Open Houses for new students to register everyone eligible. We also participate in Naturalization ceremonies to register each new citizen.

At appropriate times (usually near an upcoming election) we have people at places like Tops in the High Falls area to offer folks an opportunity to register to vote.

Social Studies/Civics teachers in city high schools have welcomed us into their classrooms where we make a power point presentation showing the history of various classes of people winning the right to vote in America. It includes a video by Lady Gaga portraying Alice Paul as she fought for the right of women to vote. The students enjoy that part, and are open to discussing the importance of voting. We identify elected officials in local, county, and state governments. We are fortunate to have on our team an LWV member from Wayne County who created the power point presentation and who has updated it to keep it current.

We meet about once a month depending on need and time of year, and would welcome you should you care to join us.

The Board approved a special use permit for a low density housing project on East River Road and Lehigh Station Road. The project plans include senior housing, housing for hearing impaired, and high-end luxury apartments.

### MONROE COUNTY LEGISLATURE 2/14/2017 OBSERVED BY ELAINE SCHMIDT AND KATE PHILLIPS

Dr. Vera Miller of the Genesee Baptist Church led the opening prayer and sang a beautiful rendition of The Lord's Prayer.

Brigit Hurley from The Children's Agenda spoke about cuts in the Nurse-Family Partnership program at the state level, the "raise the age" campaign (raising the age a youth can be tried as an adult from 16 to 18 years of age) and the need for more child care subsidies.

Legislator Bauroth once again, as he has for the last 5 years, proposed making the Democrat and Chronicle an official newspaper for the county since it has a much wider readership than the Daily Record or the Rochester Business Journal. His amendment was voted down along party lines.

The Legislature passed three resolutions "accepting the assets and liabilities" of three former LDCs: Upstate Telecommunications Corporation, Monroe Security and Safety Systems and Monroe Newpower, pursuant to an Order of Dissolution. \$100,000 was paid to Barclay Damon, LLP, from the LDC accounts for their representation in the procedure.

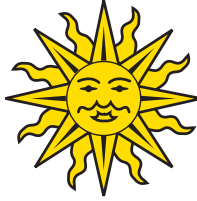
