# State Board Updates January 2022

### Local LeagueTo Do's (email: <a href="https://lwvny.org">lwvny.org</a> or fax 518-465-0812)

- Each local League MUST update the LWVUS database as to current members by Jan. 31. Members that are current should be checked off as "active" and those no longer members should be "inactive." All "active" members will be counted on Feb. 1 to determine the LWVUS and LWVNYS Per Member Payment amount as of July 1, 2022.
- Schedule a local League meeting in Feb, March or April, 2021, to discuss the proposed principles of a new position on election administration structure; responses due May 1
- Forms for students selected to attend SIA must be received by the state office by March 1.

Happy New Year everyone! 2021 is over and 2022 has begun. The issues and struggles we faced in 2021 remain. COVID is still here! Misinformation and disinformation flood the internet and social media! Politics are more partisan than ever! Voting rights are being threatened! Redistricting remains an issue! LWVNYS will continue doing what has worked well in 2022. However, we are always looking to do more!

We will continue holding presidents' zoom meetings. On January 19, our first of this year addressed leadership development. #### Redistricting

On January 3<sup>rd</sup> the Independent Redistricting Commission voted to submit two sets of maps for Congressional and state Legislative Districts, one Democratic and one Republican. Each received five votes. The League, Citizens Union and Reinvent Albany sent a letter to the Commissioners criticizing the failure to submit one set of maps. <a href="https://lwvny.org/wp-content/uploads/2022/01/Letter-IRC-010322-FINAL.pdf">https://lwvny.org/wp-content/uploads/2022/01/Letter-IRC-010322-FINAL.pdf</a>

Because the Commission voted, the Legislature had to consider both sets of maps. On January 10, they voted both sets of maps down. The Commission has 15 days to submit new maps to the Legislature. Only after those maps are voted down does the Legislature get to amend the maps We sent another letter to the Commission on January 13 asking them to come together on one set of maps after the Legislature voting down the maps. On January 24, the Commissioners of each party of the IRC released a statement blaming the other for not even agreeing to meet to discuss the 2<sup>nd</sup> set of maps. The IRC will therefore shirk its constitutional responsibility and not submit the 2<sup>nd</sup> set of maps. The League released a statement blasting the IRC's inaction (see here: <a href="https://lwvny.org/wp-content/uploads/2022/01/statement-on-IRC-inaction-Jan-25-2022.pdf">https://lwvny.org/wp-content/uploads/2022/01/statement-on-IRC-inaction-Jan-25-2022.pdf</a>).

Development of maps now falls to the hands of the Legislature. We are now working on a letter to the Legislative leaders urging transparency in their process and urging an opportunity for public input as they consider these maps.

#### **Ethics**

Governor Hochul has made abolishing JCOPE, the much-maligned New York state ethics enforcement agency her main ethics priority. Her office has been working with the good government groups, including the League on this but it will also need to be negotiated with the Legislature. She included her proposal in with her budget submission last week.

#### New Position on Election Administration and Voting for the Incarcerated

An Election Administration Structure Committee was created right after the delegates at the LWVNYS approved a new study on the topic at the state Convention in June, 2021. The Committee met many times during the fall researching:

- How other states administer elections, including speaking with administrators in some states, for a broad look at what other states do see
- Testimony from other good government groups regarding BOE reform,
- Senate Election Committee report on BOE Reform,
- Statutory reforms we have been urging in recent years

The Committee has finished the first part of its work and prepared a set of principles to be used to write a new position on how to structure election administration in New York. A full packet of materials, including the principles to be considered by each local League with their members, will be distributed in the next week. **ALL LOCAL LEAGUES SHOULD SCHEDULE A MEETING BEFORE MAY 1, 2021, TO CONSIDER THESE PRINCIPLES.** All responses will be due to the state League by May 1, 2021.

With these materials, local Leagues and members will also be asked to concur with a position allowing individuals currently incarcerated to be able to vote.

#### **Bigger Better Bottle Bill**

The League is participating in a coalition working on advocacy for a bigger better bottle bill. Watch for more info as legislative action is proposed, but share the attached fact sheet with all.

#### Gearing up for 2022!

The key in 2022 will be Getting Out the Vote (GOTV)! All voters were helped last week with the signing of legislation allowing for Voting by Absentee Ballot due to the Covid-19 Pandemic through 2022. This legislation will "ensure the pandemic does not create inaccessibility for voters during upcoming elections and help protect New Yorkers' access to the ballot," according to Governor Hochul. The legislature is currently debating other legislation in regards to voting; we will be certain current and accurate voting information is available to Leagues as the Tuesday June 28, 2022 primary election and Tuesday November 8, 2022 general elections get closer.

Thanks to our own Voter Services Committee member, Kathleen Stein, who also chairs the Rural Caucus Committee which includes several Leagues throughout the US, the VS Committee is looking to model packets created by other Leagues in rural areas on Voter Registration and Voting that can be distributed by local Leagues to libraries or other groups/organizations. We are just beginning to look into the particulars and hope to have packets available by the summer. These packets will facilitate registering voters!

The six pamphlets available from the League office on voting have been updated: First Vote, Individuals with Criminal Convictions or Detained in Jail or Prison, Homeless Individuals, College Students, Individuals with Disabilities, and Individuals with Mental Health Disabilities. These updated pamphlets will be available in March, if not sooner.

It's time to start preparing for Vote411! Vote411 at last has an updated format! There's a great training conducted by Megan Brown from the LWVUS that goes over everything a user could want to know. You can watch a recording of the training here:

This year, the State League will be handling the Congressional and NYS Senate and Assembly races in Vote 411, looking to local Leagues for assistance if a candidate does not respond. And remember the good news: Vote411 will be free of charge to all local Leagues, thanks to the generous donation received from an anonymous donor!

The 2022 Students Inside Albany Conference is currently being scheduled for May 22-25 at the Hampton Inn in downtown Albany. There is a chance that the Conference may be cancelled depending

on the pandemic or if the state Capitol is closed to visitors and the public. Forms to be completed by the students selected by each local League have been emailed to each local League. The forms are due to the state office by March 1; if forms are not received by then, the local League will lose that spot and a student will be allowed from the waiting list. All local Leagues are urged to make sure the students **and** parents know and agree to the following:

- All students will be required to show proof of being vaccinated and boosted based on CDC recommendations just prior to SIA commencing (right now that is 2 vaccines and booster could be more by May 22);
- All students must wear a mask over their nose and mouth at all times in public or common areas; and
- All students will be sharing a hotel room with another student.

Effective listening puts others in the center of our focus and thus, conveys a sense of belonging and, dare I say, inclusion. Saying we are inclusive doesn't do the trick. And since the benefits of diversifying a group include getting different perspectives, one must listen and consider the offerings that only come through to us by hearing them being expressed.

Last week while doing the Challenge, I personally came across a great list called the "Listening Sixers"! The directions were as follows: Start to listen artfully to the conversations that are taking place around you at your school, workplace, place of worship, or home. Pick a specific conversation and L-I-S-T-E-N for the following:

Did the listener welcome the speaker to the conversation in any way? Did the listener allow the speaker to express all of his or her thoughts? (...to be continued on the Better Listening Challenge Page)

Register and engage to find the remaining list of #3 – #6 additional pointers to L-I-S-T-E-N for and then process what you heard. Doing this for several days, even if just in your own household, sensitizes oneself to what works in a conversation and how a conversation fails. Then you will be ready to connect with a speaker yourself using the "**Listening Sixers**". I personally printed off a copy to serve as a readily accessible cheat sheet to consult with.

Although we have League members from across NYS enrolled and engaged in this Challenge (many thanks for your involvement), more would be great in order to effect the change we seek in our collective behavior. Please reenforce the notice of the extension to your local League members via an email blast, or just forward this email to your friends in the League, to alert them of **the newly extended deadline date of Sunday, January 30**<sup>th</sup>.
