## **Introduction: Maintaining Our Gold Standard**

The League of Women Voters is known for its expertise in conducting voter registration drives.

- It is important that we maintain our nonpartisan reputation and avoid even the appearance partisanship
- It is important that we reach out to underserved populations and low voter turnout areas.
- It is important that we train volunteers properly
- It is important that we build on our successes and collect data

During 2020, when there was a need for social distancing due to COVID, our Leagues throughout the state found new ways to register voters and train volunteers to conduct voter registration drives. By networking with other organizations and groups, especially in underserved communities, by using social media and technology, and by being creative, we reached more people than previously. Even when there is no longer a need for social distancing, Leagues are encouraged to build upon the successful networking innovations developed in 2020.

Voter registration events may be in-person, virtual, or a combination of both. When planning for voter registration drives, consider the time and place, and whether your League will run and staff the drive, or train volunteers from other organizations. You will need to decide if volunteers will be collecting completed forms and if so, who will be responsible for getting the forms to the Board of Elections. It is always important to collect data when possible. It is particularly important at in-person events where you can collect the completed voter registration forms or otherwise keep track of how many people visited the event. However, there are also ways to collect data when using social media and these should not be overlooked. Tracking and collecting data on your work is very important, not only for internal review, but because of its usefulness in securing grants *and* of course, keeping us informed at LWNYS! See sample data collecting forms on pages 18-21.

In this Toolkit, you will find a wealth of suggestions to help you plan and implement voter registration drives. , Additional resources, including: PowerPoint presentations for training of other organizations; Public Service Announcements (PSAs); and more are also available on the state League Google Drive.

### **Diversity, Equity and Inclusion**

In planning and implementing activities to encourage people to vote, Leagues should ask themselves a few questions to ensure they are including and reaching out to all people in their communities.

- How diverse is the group planning and implementing this activity?
- Are key stakeholder included?
- Does this work impact a group or community? If so, is their voice represented?
- Is the group of decision makers diverse enough?
- Does this activity help us meet the needs of underserved voters?
- Have we considered various, specific marginalized groups?
- How might our voter registration drives be perceived by the general public?

- Does this activity align with our vision for an equitable and inclusive organization?
- What further innovations could make our voter registration drives more diverse, equitable and inclusive?

## Essential Materials for In-Person Voter Registration Drives

Having all materials in portable bags or plastic bins with instructions makes it easy for volunteers. After each registration drive, refill them so they are ready for next drive:

- Table for putting out materials
- Portable chairs for LWV or other personnel plus one for people who may want to register
- Tent or shelter to protect against sun and other weather events
- iPad for online registration if available
- Voter registration forms in English and Spanish (and other languages as needed)
- Sign about VOTE411.org
- Absentee Ballot applications in English and Spanish, and other languages as needed. (Everyone can vote by absentee ballot in 2022)
- Blue and/or black pens for filling out voter registration forms
- LWV banner or identifying signs and/or posters with clearly visible statement indicating LWV never supports or opposes a candidate or party
- Voter Registration Resource Sheet with election dates, registration dates, deadlines, etc.
- Voter Registration Fact Sheet
- Voter Registration Reporting Form
- Signage: explaining who needs to register (including new voters, voters who have moved, want to change their name, change political party)
- Identifying pins, tags, and/or T-shirts for volunteers
- Box or folder to keep completed voter registration forms if collecting them
- “Remind Me to Vote” cards, pad etc.(optional)
- Stamps to sell (except in NYC) if League can afford and is not collecting forms (optional)

## INSTRUCTIONS FOR FILLING OUT THE NYS VOTER REGISTRATION FORM

**\*\*Note: form must be completed in blue or black ink only. Avoid making errors or corrections.**

The numbers below refer to the question number on the NYS Voter Registration Form

1. Check yes or no. (*U.S. Citizen means either by birth or naturalized.*)
2. Check yes or no. (Must be US citizen)  
You can register to vote if you are 16-or older, with the understanding that you must be 18 years of age by election day to vote. Until you are 18 your application will be marked “pending” and you will be unable to cast a ballot until you are 18.
3. Enter all requested information. (*Suffix refers to Jr., Sr., II, etc.*)
4. Date of birth: use numbers for your month, day and year. For example, if your birthday is July 1, 1975, write: 07/01/1975.
5. This field is optional.
6. “Telephone” is optional; you do not need to supply this information, but if there is a question about your form, your identity, your residence etc. your County’s BOE can then contact you by phone.
7. This field is optional.
8. Address where you live. Be sure to indicate the name of your County.
9. Mailing address. Fill in only if it is different from your home address (a P.O. box number, etc.).
10. Check “yes” if you have voted before, even if in another state or other NYS County.
11. Fill in the most recent year you voted before or enter a “?” if you don't remember.
12. If you voted before under a different name, a different address and/or in a different NYS County, write down what the old information was.
13. You must check one box. If you don't provide the last four digits of your SSN, or DMV number, you must bring verifiable ID information (*a valid photo ID, a current utility bill, bank statement, paycheck, government check or some other government document that shows your name and address*) the first time you vote.
14. Check only one box, either the box next to the party of your choice, or the box next to “I do not wish to enroll in a party.” Only voters registered in a particular party can vote in that party’s primary. Choosing a party does not require you to vote for that party’s candidate in the general election. You do not need to enroll in a party.
15. Two optional boxes: Check the appropriate box to request an absentee ballot application, or to indicate that you want to be an Election Day worker.
16. Read, sign, and date.

*Reverse side of NYS voter registration form includes mailing addresses for all NYS County Boards of Elections (BOE). Completed form MUST be mailed to the County BOE of the voter’s address. (Note that all 5 NYC boroughs mail to the Broadway address)*

*Consider becoming an Organ Donor. New York has the third highest need for donors in the US, yet the second lowest percentage of registered donors. Complete form on the reverse side.*

If you do not receive a Confirmation of Registration from your local Board of Elections within a reasonable time after mailing your registration form, call them to make sure your application was received. Local Boards of Elections send registered voters a non-forwardable postcard prior to the election to verify their residence, and to inform them of the location of their polling place. If you do not receive this card, call your Board of Elections to make sure there is no problem with your registration.

## **VOTER INFORMATION RESOURCES**

### **IMPORTANT DEADLINES FOR THE NOVEMBER 8, 2022 GENERAL ELECTION**

- October 14, 2022 - Last day to postmark voter registration form (must be received by October, 2022) or register in person at BOE
- February 14, 2023 – last day to change party enrollment for 2023 primaries
- October 24, 2022 – last day to postmark application or letter of application for absentee ballot
- October 24, 2022 – last day to apply for absentee ballot using online portal
- October 29, 2022- early voting starts and is available through November 6, 2022
- November 6, 2022 – early voting ends
- November 7, 2022 – last day to apply in person for absentee ballot
- November 8, 2022 – last day to postmark absentee ballot for general election; must be received by the county BOE no later than Nov 15<sup>th</sup>
- November 8, 2022 – last day to deliver absentee ballot in person to your county Board of Elections or to poll site by close of polls
- If you have applied for an absentee ballot, but show up to vote in person at the polls you will not be allowed to vote via an in-person ballot, but will instead need to vote by affidavit ballot
- IF YOU HAVE MOVED WITHIN NYS, YOU DO NOT NEED TO RE- REGISTER. This a new law, so we recommend that if you move, submit a Voter Registration form with your new information.

#### **ARE YOU GOING AWAY TO COLLEGE?**

- If you want to vote in your college election district, you have to register in that district. Go to that state's Board of Elections' website for details. Some states make it difficult to impossible for out of state students to vote.
- To vote in your home district you will need an Absentee Ballot application mailed to your college address. For details: <http://www.elections.ny.gov/VotingAbsentee.html>

#### **DEADLINE TO CHANGE PARTY ENROLLMENT**

If you want to change your party enrollment for the **2023 PRIMARY ELECTIONS**, you must fill out a voter registration form by **February 14, 2023**.
