President's Report, Judie Gorenstein, judieL728@aol.com

As we start a new year 2023, I have to say how proud I am to be president of the LWVNY. This year has only begun, but we have already successfully closed on our building, received unexpected donations, held an outstanding Legislative Hot Topics webinar where over 100 attendees learned more about how we adopt and takes action on issues, as well as hearing from each of our issue specialist. Thanks to our staff, the specialist, and also the LWV of Albany initiated this program. This is an excellent example of how LWVNYS and local Leagues work together.

In addition on January 19th, we held our presidents' zoom meeting; Past, Present and Future. There was brief look back to successes in 2022 as well as goals not achieved. It is always important to acknowledge our success and strengths. Success begets success. It is also important to look at the weaknesses so we can make changes and overcome. Successes included presidents' zoom meetings, presidents' google group, and 100% response to voter service survey. However, only 20 to25 Leagues have responded to other surveys and data collection. Although there have been a lot of surveys and Leagues at times may feel overwhelmed, the data is needed and this is area where Leagues can do better.

In the fall, LWVNYS was pleased to provide pass through grants for GOTV projects but some Leagues that were awarded these have not followed through on either implementation or reporting. Those who did were acknowledged but the importance of all Leagues doing so was stressed. This is area where Leagues can do better. Leagues who have had successful programs or new ideas as always were encouraged to share. Susan Ferris president of LWV of Northeast Westchester had notified us of receiving a grant from LWVUS. Leagues were asked to indicate in chat if they had received grants and if for youth or criminal justices. Nine Leagues indicated they had and there may be more. In the future, we will be sharing more information on all the projects our Leagues have done, so if you have not informed LWVNY that you received such a grant please do so.

Deb Brodheim, LWV of NYC co-president, shared their successful Constitutional Day events and provided information for others to use in future. Kathy Meany president of LWV Westchester ILO discussed plans to start new a MAL Unit in NW Westchester County. This is particularly important because although LWV has increased power and visibility and made a difference, our number of members and Leagues have not grown.

We need to do better, but how? This year, LWVNYS is implementing a new initiative using a regional approach to League communication and collaboration. Leagues and MAL Units have been divided into six regions with a member of the state Local League Support committee assigned to each. A list of the regions with the liaisons was presented during the zoom. The objective is to create these smaller regional groups to share experiences and issues and to HELP each other with ideas, programs and practices to resolve issues that one or all have encountered. The liaisons have already or will be contacting the presidents of their Leagues in the next couple of weeks to solicit topics they would like addressed and then will schedule the zoom meetings for their regions. We are hopeful that this new initiative will be helpful to strengthen and grow our Leagues and will be evaluating the process as we move forward.

The presidents' zoom meeting ended with Laura discussing future opportunities and plans for Feb 14th and the upcoming LWVNYS convention. Feb 14, 2023 will be the 103rd anniversary of the LWVUS. LWVUS has called for a Day of Action. They have provided webinars and also a toolkit of what Leagues can do. LWVNYS is encouraging our Leagues who have not yet initiated anything special to organize a table at local colleges to provide advocacy information to students and information on the Equal Rights Amendment that passed both houses in NY on January 24. LWVNYS will provide materials and stickers to those Leagues who do. Seven Leagues have already notified us, but if your League has planned to and not contacted us, please do. Also remember to post on social media and send LWVNYS photos of whatever you do. Let's be visible on February 14th and begin plans for LWVNYS Convention in June. Hope to see many of you there!

This year as in past, it is important we all work together!

LWVUS Data Tracking

The state League is so pleased to report that 24 local Leagues submitted responses to the monthly data tracking form for activities in December. And, we are again astounded by the results from just 24 local Leagues:

- 64 educational events/rallies/forums were held
- 147 events were held focusing on the mechanics of voting (requirements, procedures, etc)

- Over 780 individuals were engaged in League work in-person
- Over 935 individuals were engaged in League work virtually
- 46 other organizations partnered with Leagues to do the work

Keep up the great work – these numbers are from just December's activities which is usually a slower month and see how much you all accomplished! Legislative Agenda

The state League has again created a Legislative Agenda booklet in which the current legislative issues to be considered by the state League are described. These items will be the ones monitored and on which we will take action during the upcoming legislative session. The state League shipped copies of this booklet to all local Leagues at no charge. Please use the booklet when meeting with elected officials, at membership meetings, and to educate potential members about the League's positions.

Legislative Priorities

As the legislative session approaches, the State League is beginning to meet with coalition partners to make plans for our advocacy efforts in the coming year. Recommendations made by local Leagues will once again be used to help determine the amount of resources given to each of the issues and on what issues members are most interested.

State of the State

The Governor gave her annual State of the State on Tuesday of this past week and we were watching from the overflow room in the Legislative Office Building.

Governor Hochul started off by reviewing several accomplishments from the past year before discussing her priorities for the upcoming year. Largely, the focus of the speech was what we expected. Below are a few of the highlights. <u>Click here to read her speech in full</u>.

- Introduction of the New York Housing Compact, which will build over 800,000 new homes over the next decade.
- A plan to fix New York State's continuum of mental health care
- Several public safety initiatives
- A plan to index NY's minimum wage to inflation
- A cap-and-invest program to combat climate change
- Making child care more affordable and accessible

It was the first time in many years that neither democracy nor ethics was mentioned in a State of the State speech.

Senate Voting Rights/Election Reform Package

As they have for the past four years, the Senate introduced a package of bills last Monday to address voting rights and election reform. Read more about the package <u>here</u>. The League was quoted in a press release that went out about the package- <u>click here</u> to read the press release.

All of the bills introduced were passed in the Senate with several receiving bi-partisan support. A huge win was the passage of S657, which establishes the New York voting and elections database and institute to maintain a statewide database of voting and election data. This bill is the companion bill to the John R. Lewis New York Voting Rights Act, which the League supported last session. There has not been much movement on any of the bills in the Assembly.

NYS Election Commissioners Association Conference

This week the State League attended the NYS Election Commissioners Association Conference in Albany. We spent multiple days with commissioners from across the state, attending sessions led by the State Board of Elections and county commissioners.

The League also staffed a table with several of our coalition partners where we were able to distribute information on election security and talk with county commissioners about how we could best support their efforts to reach voters across the state.

NYS Equal Rights Amendment Taskforce

The week of January 9th, the State League launched the statewide LWV ERA Taskforce to work on second passage of the New York State Equal Rights Amendment. We have representation from 30 Leagues and 36 members. We expect to add more delegates as we get closer to a vote in 2024.

The bill passed for a second time in both the Senate and Assembly on January 24th—two days after the 50th anniversary of Roe v. Wade. The taskforce will now launch a statewide voter education campaign before voters have a chance to vote on the bill in November of 2024. If voters approve the amendment it would prohibit discrimination against groups who have been historically targeted, including those with disabilities, LGBTQI+ individuals, immigrants, women, and pregnant people. It would also codify abortion access in our state constitution. If your League has not given us the name of a delegate, please email that name and contact info to Erica@lwvny.org.

Legislative Hot Topics Webinar

On Saturday, January 21st the LWVNYS and the Albany County League held a Legislative Hot Topics webinar for all members. We had 8 issue specialists and issue committee chairs on the call in addition to the State Issues Committee. The presentation focused on how NYS does advocacy and how members can get involved. Each issue specialists/committee co-chair had time to talk about their committee's priority bills and which legislative issues will have the most traction this session. <u>Click here</u> for a recording of the session and <u>click here</u> for the PowerPoint, both of which have been posted on our homepage.

10 Day Voter Registration Bill Signed

Governor Hochul signed the 10-day voter registration bill into law on December 23, 2023. The law took effect January 1, 2023. Chapter amendments to the law recently passed in the Senate (S1327/A972) and are in committee in the Assembly. The chapter amendments make changes to current election law to account for the new 10-day registration deadline. We are looking more closely at the chapter amendments to ensure there are no unexpected implications. In order for a 10-day registration deadline to be enacted effectively implementing legislation must be passed and signed into law this session. The most popular implementation bill is one introduced by Senator Myrie last session (S1552 (2021-2022 session). This bill would allow for affidavit voting at poll sites on the first day of early voting and require local BOEs to confirm eligibility on the back end.

Program Planning for State Convention 2023

As it does every year in which there is a state convention, the State League sent all local Leagues information on how to help develop a State Program, i.e. suggesting of new issues to be selected for concentrated study, which positions need to be updated, and whether any existing positions should be dropped for 2023-2025. This discussion can be done at a Board meeting but we urge Leagues to seek as much member input as possible in developing their response. The response is due to the State League **by March 1** in order to be considered by state Board and then at Convention. The packet and form to return are attached to this email.

10 Day Registration Signed by Governor

A huge win for voters in NY State as Governor Hochul just signed the 10-day Voter Registration bill (S2951A/A8858A) which will reduce the voter registration deadline to the constitutional minimum of ten days! This bill went into effect January 1, 2023 but requires implementing legislation and more – look below at Advocacy report for more information!

February 14th — Valentine's Day — of each year is the final day for voters to change their party registration before a primary election (this June). Voters wishing to change their party affiliation, as with any new voter registration or address change, can use the online voter registration form available through the state Department of Motor Vehicles New York at https://dmv.ny.gov/more-info/electronic-voter-registration-application or can fill out and mail a new voter registration form New York State Voter Registration Form available on the state League website or the state Board of Elections website. Remind members and the voting public of this important annual date to change party affiliation!
