This year in New York, voters can register up until 10 days before Election Day. The 10 day voter registration bill became law on Dec,. 23, 2022 and became effective January 1, 2023. While we still do not have same day registration, this change did not require a constitutional amendment and certainly make it easier for people to register and voter. New Yorkers need to know and who better than the LWV to educate and register them.

On January 24th, both houses passed the ERA amendment which New York one step closer to our goal of codifying basic protections to all New Yorkers. Although this will not be on the ballot until 2924, now is the time to begin educating voters about all the rights that need to be and can be protected by this bill.

On Feb 14th, LWVUS will celebrate its 103rd birthday. This is a day to celebrate and for action. Find out what your league is doing and join in the celebration and actions. Be proud to be a member of the LWVNY.

June 3rd-June 4th is LWVNY Convention. After three years of virtual conventions, this will be in person and a wonderful opportunity to meet members from all parts of the state and participate whether you are a delegate or not.

LWVNY is making major efforts to keep our members informed on not only what is happening in Albany but what our members can do.

State of the State

The Governor gave her annual State of the State on Tuesday of this past week and we were watching from the overflow room in the Legislative Office Building.

Governor Hochul started off by reviewing several accomplishments from the past year before discussing her priorities for the upcoming year. Largely, the focus of the speech was what we expected. Below are a few of the highlights. Click here to read her speech in full.

- Introduction of the New York Housing Compact, which will build over 800,000 new homes over the next decade.
- A plan to fix New York State's continuum of mental health care
- · Several public safety initiatives
- A plan to index NY's minimum wage to inflation
- A cap-and-invest program to combat climate change
- · Making child care more affordable and accessible

It was the first time in many years that neither democracy nor ethics was mentioned in a State of the State speech.



Senate Voting Rights/Election Reform Package

As they have for the past four years, the Senate introduced a package of bills last Monday to address voting rights and election reform. Read more about the package **here**. The League was quoted in a press release that went out about the package-**click here** to read the press release.

All of the bills introduced were passed in the Senate with several receiving bi-partisan support. A huge win was the passage of S657, which establishes the New York voting and elections database and institute to maintain a statewide database of voting and election data. This bill is the companion bill to the John R. Lewis New York Voting Rights Act, which the League supported last session. There has not been much movement on any of the bills in the Assembly.

NYS Election Commissioners Association Conference

This week the State League attended the NYS Election Commissioners Association Conference in Albany. We spent multiple days with commissioners from across the state, attending sessions led by the State Board of Elections and county commissioners.

The League also staffed a table with several of our coalition partners where we were able to distribute information on election security and talk with county commissioners about how we could best support their efforts to reach voters across the state.

NYS Equal Rights Amendment Taskforce

The week of January 9th, the State League launched the statewide LWV ERA Taskforce to work on second passage of the New York State Equal Rights Amendment. We have representation from 30 Leagues and 36 members. We expect to add more delegates as we get closer to a vote in 2024. The bill passed for a second time in both the Senate and Assembly on January 24th—two days after the 50th anniversary of Roe v. Wade. The taskforce will now launch a statewide voter education campaign before voters have a chance to vote on the bill in November of 2024. If voters approve the amendment it would prohibit discrimination against groups who have been historically targeted, including those with disabilities, LGBTQI+ individuals, immigrants, women, and pregnant people. It would also codify abortion access in our state constitution.

Legislative Hot Topics Webinar

On Saturday, January 21st the LWVNYS and the Albany County League held a Legislative Hot Topics webinar for all members. We had 8 issue specialists and issue committee chairs on the call in addition to the State Issues Committee. The presentation focused on how NYS does advocacy and how members can get involved. Each issue specialists/committee co-chair had time to talk about their committee's priority bills and which legislative issues will have the most traction this session. 10 Day Voter Registration Bill Signed

Governor Hochul signed the 10-day voter registration bill into law on December 23, 2023. The law took effect January 1, 2023. Chapter amendments to the law recently passed in the Senate (S1327/A972) and are in committee in the Assembly. The chapter amendments make changes to current election law to account for the new 10-day registration deadline. We are looking more closely at the chapter amendments to ensure there are no unexpected implications. In order for a 10-day registration deadline to be enacted effectively implementing legislation must be passed and signed into law this session. The most popular implementation bill is one introduced by Senator Myrie last session (S1552 (2021-2022 session). This bill would allow for affidavit voting at poll sites on the first day of early voting and require local BOEs to confirm eligibility on the back end.

February 14th — Valentine's Day — of each year is the final day for voters to change their party registration before a primary election (this June). Voters wishing to change their party affiliation, as with any new voter registration or address change, can use the online voter

registration form available through the state Department of Motor Vehicles New York at https://dmv.ny.gov/more-info/electronic-voter-registration-application or can fill out and mail a new voter registration form New York State Voter Registration Form available on the state League website or the state Board of Elections website. Remind members and the voting public of this important annual date to change party affiliation!

Your DEI Task Force met in December, preparing to have a busy year in 2023, beginning with:

- DEI Self-Assessment Survey: To be issued shortly to all NYS League Chapters and for individual member inputs. It was completed initially back in 2020 by those NYS Leagues that had representation on the Task Force and by the State League Board. And since then, the LWVNYS Task Force and this Office of the 3rd Vice President for DEI, have provided numerous methods to learn about DEI in support of National's stance that DEI is as important to uphold in principle and practice as is our concept of nonpartisanship. The Assessment Survey will need to be completed by April 1st by all of our local league chapters through the consensus of their Board of Directors. Members not on Boards are invited to submit individual surveys. You will be notified when the final version of the DEI Assessment is ready for your input and submission.
- Education: Is a nonending endeavor as we transform into a "continuous learning" organization. Local League News

Rochester Metro Area

The Rochester Metro League recently hosted an educational webinar panel titled *Mental Health Crisis Response: How Has It Changed Since Daniel Prude?* In the wake of Daniel Prude's death at the hands of the police, the city of Rochester established the Person In Crisis team (PIC) to handle 911 cases that involve mental health crises that don't involve a crime or a weapon. The panel discussed PIC's work so far in taking mental health calls off the hands of police. Panel members included Manager of Crisis Intervention Services in the City of Rochester Alia Henton-Williams, Vice President of Rochester City Council Mary Lupien, co-

founder of MC Collaborative Andy Carey, Person-Centered Housing Options Outreach and Engagement Team Lead Lisa Kuhmann, and a member of the PIC team.

New York City

The New York City League hosted its first Lunch with the League event of 2023 titled *What to Know about NYC's Migrant Crisis*. New York City Mayor Eric Adams declared a state of emergency to address a "crisis situation" over an influx of migrants, many of whom are families with school-aged children and are in serious need of medical care, to the city from the border states. The League heard from Office of Immigrant Affairs Commissioner Manuel Castro as he discussed how the situation is being handled.

Albany County

The League of Albany County hosted *Pinocchio Revisited: Separating Fact from Fiction*, which explored the evolution of mis and disinformation on social media. Director of Communications at the University at Albany and former Times Union reporter Jordan Carleo-Evangelist discussed the spread of misinformation and how it has contributed to a radically divided country. After a luncheon, attendees shared stories of misinformation and/or disinformation they had come across in the past, with the most egregious tall tale winning the "fisherman's award."

Cooperstown

After a two-year hiatus, the Cooperstown League hosted its annual Winter Doldrums Party! For more than thirty years the League's Winter Doldrums party had been the highlight of the League's year. League members participated in a silent and chased away winter blues while getting to know fellow League members outside of the constraints of a meeting.

Albany, Rensselaer, Saratoga, and Schenectady

The capital region Leagues hosted a virtual panel discussion about religious medical systems and bodily autonomy. With the rise in mergers between secular community hospitals and religious hospitals, more and more people are being denied the care that they are otherwise lawfully able to obtain. The League was joined by experts who discussed he impact of religious directives that dictate the kinds of care that healthcare facilities that are owned or affiliated with religious institutions can and cannot deliver to their patients.
