Presidential Primary in NYS: April 2, 2024 Early Voting: March 23 – 30, 2024

Date	Deadline Information
February 14	Last day to Change Party Enrollment for the Primaries in April and June. The voter registration form should be used to change your party enrollment from one party to another or to enroll for the first time in a party. An application to change one's party enrollment for the primary election in any year must be received by the board of elections no later than February 14th of that year. Changes received on or after February 15th until seven days after the June Primary will be set aside and opened seven days following the June Primary and entered in the voter's registration record.
March 23	Last day voter registration must be received by BOE's by MAIL or IN PERSON.
April 1	Last day to apply IN PERSON for an absentee ballot
April 2	Last day to postmark ballot and the postmarked ballot envelope must be received by the BOE by April 9, 2024.
April 2	Last day to deliver ballot IN-PERSON to the local Board of Elections or to any poll site in your county.

Bills Requiring Governor Signature Out of our priority bills from last session the following still need to be signed: Birds and Bees Protection Act (**S01856** Hoylman-

Sigal/A03226 Glick)

• School Based Health Centers (S2339 Rivera/A6029 Paulin)

Legislation we opposed that passed, but is not signed is below:

• Revisions to the New York State Public Campaign Finance Program (S7564/A7760)

Bills that have been signed by the Governor since our last update are listed below:

- Plain Language Ballot Initiative (S1381 Comrie/A1722 Zinerman). This bill was signed on November 17th.
- Clean Slate (**S211A** Myrie/ **A1029A** Cruz). This bill was signed on November 16, 2023. The State League was invited to this bill signing and a member from the LWVNYS Criminal Justice Reform Committee, Hazel Weiser, represented the State League at the event in Brooklyn.

COELIG Roundtable

Along with the other good government groups, the League was invited to participate in a roundtable discussion regarding the 2024 legislative agenda for the Commission on Ethics and Lobbying in Government (COELIG) in November in NYC. We made recommendations regarding sexual harassment, financial disclosure for candidates, and the legislative ethics commission. We felt the roundtable went well and that commissioners were generally receptive to ideas from the good government organizations. COELIG ultimately made a few small changes to their legislative agenda in response to this collaboration.

Local League News

Mid-Hudson League

After all the important changes in New York State Election Law benefiting incarcerated citizens last year, members of the Mid-Hudson League took the reins and set out to educate people at the Ulster County Jail. Members Christine Hunter and Cindy Bell were joined by Ulster County Board of Elections Commissioner Ashley Torres (D) and Deputy Commissioner Keri Williams (R), as well as Ulster County Jail's Officer Lacey.

Officer Lacey led the group through the six jail units, announcing their presence at each and allowing them to speak with the incarcerated individuals and help them complete forms and answer questions. All in all, the group came away with 16 registrations and 31 absentee ballot applications. At the end of the visit, Ashley and Keri took the documents back to the BOE and got to work to make sure everyone got the appropriate ballot.

New York City

Pat Manning, a longtime member of the New York City League, was recently featured in the We ♥ NYC Do-ers campaign! We ♥ NYC is a public-private partnership created with the support of Governor Hochul and Mayor Adams to promote New York City and encourage volunteer action. Part of the We ♥ NYC campaign is recognizing New Yorkers who take action to help their neighbors and their city, and Pat is one of those exceptional people. Oneonta

The Oneonta League held two on-campus registration events this fall. LWVO members Stephanie Bauer, Janet Sutta, Nancy Mathisen, Sarah Paterson, and David Hutchison registered voters on the SUNY Oneonta campus on September 19, National Voter Registration Day. The League teamed up with students from Oneonta's Cooperstown Graduate Program in Museum studies for the first time! Students helped with registration and designed a sign that advertised the event. Volunteers registered eight voters, but also handed out "Make a Plan to Vote" sheets and other election materials.

Next door at the Hartwick College campus, member Zach McKinney and his students registered voters on National Voter Registration Day and throughout the month. All told, 118 voters were registered.

Utica-Rome

On a crisp fall day, members of the Utica-Rome League were treated to a guided walking tour of 5 historical sites in downtown Utica by former Utica University professor Jan J. DeAmicis. The Oneida County Freedom Trail Commission was organized as part of a response to the National Park Service initiative to identify and preserve sites concerning the Underground Railroad nationwide.

Cortland County

In addition to their usual Election Day GOTV efforts, the Cortland County League went out of its way to honor the people who make democracy happen: poll workers. League member Kim Cameron came up with the idea to distribute thank-you cards to poll workers the morning of Election Day. Workers were thrilled! In addition to the thank-you message, Kim included an invite to join the Cortland League their November Open House - a very informal event to inform people about what the League does.

Northeast Westchester, New Castle, and Rivertowns

The Northeast Westchester, New Castle, and Rivertowns Leagues teamed up to host a presentation on New York State's Medical Aid in Dying Act (A995a/S2445a). Speakers included Assemblymember Amy Paulin, who is one of the bill's sponsors and chair of the Assembly's Health Committee; and Doctor Maggie Carpenter, medical director at Hudson Valley Hospice and the Mid-Hudson Family Practice Residency in Kingston. An audience Q&A followed the presentation.

Albany County

Albany County League members Anne Erling, Christine Primomo, Paula Brewer and Cathy Dryden attended the November 20, 2023 NYS Department of Environmental Conservation hearing on Norlite's ash waste handling. Cathy presented testimony on behalf of LWVAC. <u>Read the complete testimony here.</u>
